Declaration by the Netherlands

The Netherlands hereby declares that, pursuant to Article 9(3) of the Council Framework Decision, it can consent to the forwarding of a decision on supervision measures if the person concerned requested the forwarding and if there is a demonstrable and sufficient link with the Netherlands.
