Subject:	Implementation of the Council Framework Decision 2008/909/JHA on the application of the principle of mutual recognition to judgments in criminal matters imposing custodial sentences or measures involving deprivation of liberty for the purpose of their enforcement in the European Union - Notification by Romania

I have the honor to notify the General Secretariat of the Council of the European Union on the implementation by Romania of the **Council Framework Decision 2008/909/JHA of 27 November 2008** on the application of the principle of mutual recognition to judgments in criminal matters imposing custodial sentences or measures involving deprivation of liberty for the purpose of their enforcement in the European Union (hereinafter referred to as FD).

By the Law no. 300 from 15 November 2013 for the amendment and supplemental of the Law no. 302/2004 on the international judicial cooperation in criminal matters, published in the Official Gazette of Romania on 11 December 2013 Romania transposed the Framework Decision no. 2008/909/JHA of 27 November 2008 on the application of the principle of mutual recognition to judgments in criminal matters imposing custodial sentences or measures involving deprivation of liberty for the purpose of their enforcement in the European Union.

The legal provisions concerning the transposition of the aforementioned FD entered into force within 15 days from the publication date in the Official Gazette of the transposing law, respectively on 26 December 2013.

Based on the pertinent provisions of its legislation, Romania formulates the following notifications and statements referring at the application of the aforementioned Framework Decision:
