## ACT

ON THE AMANDMENT TO THE ACT ON JUDICIAL COOPERATION IN CRIMINAL  
MATTERS WITH MEMBER STATES OF THE EUROPEAN UNION

## Article 1

In the Act on Judicial Cooperation in Criminal Matters with Member States of the European Union (Official Gazette, Number 91/10 and 81/13), in Article 132.a., paragraph 3 is being deleted.

## Article 2

This Act shall be published in the *Official Gazette of the Republic of Croatia*, and shall enter into force on 1 January 2014.
