Dear Director-General,

I am pleased to inform you that, in accordance with Article 27(2) of **Council Framework Decision 2009/829/JHA of 23 October 2009 on the application, between Member States of the European Union, of the principle of mutual recognition to decisions on supervision measures as an alternative to provisional detention** (published in the *Official Journal of the European Union*, OJ L 294, 11 November 2009), I have informed the General Secretariat of the Council and the European Commission that the Czech Republic has implemented the Framework Decision in its domestic law.

The provisions of the Framework Decision were enacted in Czech law by Law No 104/2013 on international judicial cooperation in criminal matters, which **will enter into force on 1 January 2014.**

**Notification by the Czech Republic under Article 6(1) of Council Framework Decision 2009/829/JHA of 23 October 2009 on the application, between Member States of the European Union, of the principle of mutual recognition to decisions on supervision measures as an alternative to provisional detention**

Competent authorities

1. Where the Czech Republic is the issuing state, these are:

- all courts (district courts, regional courts, high courts, Prague and Brno Municipal Courts and the Supreme Court);
- all prosecutors' offices (district and regional prosecutors' offices, high prosecutors' offices, Prague and Brno Municipal Prosecutors' Offices and the Supreme Prosecutor's Office).

2. Where the Czech Republic is the executing state:

- these are the locally competent district courts. District courts can be contacted at the addresses given in Annex 2;
- regional courts decide as regards legal remedies.

**Notification by the Czech Republic under Article 9(4) of Council Framework Decision 2009/829/JHA of 23 October 2009 on the application, between Member States of the European Union, of the principle of mutual recognition to decisions on supervision measures as an alternative to provisional detention**

The Czech Republic hereby gives notice pursuant to Article 9(4) that decisions on supervision measures may be forwarded to the competent judicial authorities of the Czech Republic even where a person in respect of whom a decision of another Member State is issued does not have his/her ordinary residence, if:

- (a) the person in respect of whom that decision is issued asks for it to be sent to the Czech Republic for the purpose of its recognition and enforcement;
- (b) the person in respect of whom that decision is issued is present in the Czech Republic or it may reasonably be supposed that he/she intends to stay here; and
- (c) the sole judge agrees to take over the decision of that Member State for the purpose of recognition and enforcement in the Czech Republic, on the grounds that it is appropriate and efficient to do so, in terms of ensuring a successful operation as regards the person and effective monitoring of his/her activities.

**Notification by the Czech Republic under Article 21(3) of Council Framework Decision 2009/829/JHA of 23 October 2009 on the application, between Member States of the European Union, of the principle of mutual recognition to decisions on supervision measures as an alternative to provisional detention**

The Czech Republic hereby gives notice pursuant to Article 21(3) that it will apply Article 2(1) of the Framework Decision on the European Arrest Warrant in deciding on the surrender of the person concerned to the issuing State.

In accordance with the provisions of Article 256(2) of Act No 104/2013 on international judicial cooperation in criminal matters, the Ministry, at the request of a court, and the Supreme State Public Prosecutor's Office, at the request of a prosecutor, shall offer cooperation in securing required information, in particular in determining the competent authority of another Member State to which a decision is to be sent or in verifying the conditions established by the legal system of that Member State for the recognition and enforcement of that decision.

The Ministry shall offer the same cooperation at the request of an authority of another Member State in obtaining required information, where it concerns competent authorities of the Czech Republic or the verification of the conditions established by the legal system of the Czech Republic.
