

In accordance with subparagraph a) and c) of paragraph 1 of Article 33 of the Directive 2014/41/EU of the European Parliament and of the Council of 3 April 2014 regarding the European Investigation Order in criminal matters the competent authorities of the Republic of Latvia for issuing European Investigation Order and the competent authorities for sending European Investigation Order are:

1. In the investigation stage the European Investigation Order is issued by person directing the proceedings, namely, an investigator or in special cases a prosecutor. According to Article 2 (c) (ii) of the Directive, the European Investigation Order issued by the investigator is approved by the prosecutor. The competent authorities that are responsible for sending the European Investigation Order to the competent authority of the member state of the EU are State Police and Prosecutor General's Office.
2. In the prosecution stage the European Investigation Order is issued by prosecutor. The competent authority that is responsible for sending the European Investigation Order to the competent authority of the member state of the EU is Prosecutor General's Office.
3. In the trial the European Investigation Order is issued by the court and the court sends the European Investigation Order to the competent authority of the member state of the EU. In case the court cannot determine the competent authority of the member state of the EU, the European Investigation Order is sent to the competent authority of the member state of the EU by the Ministry of Justice.

The competent authorities of the Republic of Latvia for receiving and execution of the European Investigation Order are:

1. In the pre-trial proceedings, the Prosecutor General's Office receive, examine and recognise a European Investigation Order, and up to the commencement of prosecution – also the State Police.
2. After transfer of a case to the court a European Investigation Order is received, examined and verified by the Ministry of Justice, whereas the decision regarding recognition and execution is taken by the court.
3. An executing authority is any investigating institution, a unit of the prosecutor's office or court to which a competent authority of Latvia (as mentioned before: Prosecutor General's Office, State Police, the court) has assigned to execute a European Investigation Order.

A list with contact details of competent authorities of the Republic of Latvia for receiving and sending European investigation orders are added in the Annex.

Regarding subparagraph b) of paragraph 1 of Article 33 of the Directive 2014/41/EU of the European Parliament and of the Council of 3 April 2014 regarding the European Investigation Order in criminal matters the Republic of Latvia informs that the accepted language for European Investigation Orders is Latvian and English.
