**Statement by the Republic of Austria pursuant to Article 6 of Council Framework Decision 2002/584/JHA of 13 June 2002 on the European arrest warrant and the surrender procedures between Member States**

- Article 6 of the Framework Decision (authorities competent to issue and execute a European arrest warrant):

The authorities competent to issue and execute a European arrest warrant are the prosecution services at the headquarters of the regional court (*Landesgericht*).

The European arrest warrant is to be transmitted to the prosecution service in whose jurisdiction the requested person is resident or located; failing that, the prosecution service in whose jurisdiction the person was apprehended is competent. If the requested person is in custody, the place of custody is the decisive factor. If, pursuant to these provisions, no particular prosecution service emerges as being competent, the Vienna prosecution service (*Staatsanwaltschaft Wien*) will be competent.
