**Declaration of the Czech Republic to the Council Framework Decision 2002/584/JHA of 13
June 2002 on the European arrest warrant and the surrender procedures between
Member States**

Declaration to Article 6(3)

Authorities competent to issue a European arrest warrant in the Czech Republic are District, Regional and High courts, Municipal Court in Prague, Municipal Court in Brno and Supreme Court of the Czech Republic.

Authorities competent to execute a European arrest warrant in the Czech Republic are Regional Prosecutor's Offices, Municipal Prosecutor's Office in Prague, Regional courts, High Courts and Municipal Court in Prague.

Authorities competent to receive a European arrest warrant issued by another Member State are Regional Prosecutor's Offices and Municipal Prosecutor's Office in Prague. Contact details are contained in the Annex.

Declaration to Article 7(1)

Ministry of Justice of the Czech Republic, Supreme Prosecutor's Office of the Czech Republic and Police Presidium of the Czech Republic are the central authorities designated to assist the judicial authorities. Contact details are contained in the Annex.

Declaration to Article 8(2)

The Czech Republic shall accept a European arrest warrant produced in the Czech language or accompanied by translation into the Czech language. In relation to the Slovak Republic the Czech Republic shall accept a European arrest warrant produced in the Slovak language or accompanied by translation into the Slovak language.

Declaration to Article 25(2)

Authority competent to receive transit requests in the Czech Republic, including necessary documents related to transit requests, is the Supreme Court of the Czech Republic. Contact details are contained in the Annex.

Declaration to Article 31

The Czech Republic shall continue to fully apply the European Convention on Extradition of 13 December 1957, its two additional Protocols of 15 October 1975 and of 17 March 1978, as well as the relevant provisions of Title III Chapter 4 of the Convention of 19 June 1990 implementing the Schengen Agreement of 14 June 1985 on the gradual abolition of checks at their common borders, which are binding and applicable for the Czech Republic. The Czech Republic shall thus proceed until it notifies the Secretary General of the Council of Europe in accordance with Article 28(3) of the European Convention on Extradition.

Declaration to Article 32

The laws implementing in the Czech Republic Council Framework Decision 2002/584/JHA of 13 June 2002 on the European arrest warrant and the surrender procedures between Member States shall be applicable to acts committed after 1 November 2004.
