Following the entry into force in Poland of the Framework Decision of 13 June 2002 on the European arrest warrant and the surrender procedures between Member States, please find enclosed Poland's notifications with regard to the Framework Decision.

The European arrest warrant is the first concrete measure in the field of criminal law to implement the principle of mutual recognition, which the Tampere European Council described as the "cornerstone" of judicial cooperation. We are pleased to be able to contribute to establishing the area of freedom, security and justice. This notification provides me with the opportunity to express our gratitude for the support lent by Directorate-General H (JHA) in our efforts to implement the new *acquis communautaire* in the field of JHA.
