Sir,

In order to comply with the provisions of Framework Decision 960/2006 on simplifying the exchange of information between law enforcement authorities of the Member States of the EU (OJ L 386, 29.12.2006, p. 89; corrigendum OJ L 75, 15.3.2007, p. 26) we wish to make the following declaration:

**The competent law enforcement authority in Romania** within the meaning of the provisions of Article 2(a) of Framework Decision 960/2006 is the **Ministry of Internal Affairs and Administrative Reform**, which includes the Police, the Border Police, the Gendarmerie and the International Police Cooperation Centre as structures which collect and process information and intelligence within the meaning of the Framework Decision;

In compliance with Article 6(1) of Framework Decision 960/2006, **the designated national contact for the exchange of police information and intelligence is**, in accordance with the provisions of national legislation – *Government Emergency Ordinance No 103/2006 concerning measures to facilitate international police cooperation*, ratified by Law No 104/2007, *Monitorul Oficial* [Official Gazette] No 275/25.04.2007:
